CAGE's ULTRA CASH Caribbean Progressive Jackpot
Rules and Regulations of Play

RULES AND REGULATIONS

April 27th, 2026

These Rules and Regulations detail the specifics of CAGE's ULTRA CASH Caribbean Progressive Jackpot ("ULTRA CASH"), a game offered by and under the auspices of CAGE (St Kitts-Nevis) Ltd. (hereinafter "CAGE"). CAGE's ULTRA CASH is a regional multi state, multi-currency mystery progressive jackpot game with participation of play from CAGE's multiple jurisdictions in which CAGE operates, including, without limitation, Antigua and Barbuda, Barbados, Guyana, and Saint Lucia. A percentage of play from eligible games contribute to the common ULTRA CASH prize amount displayed in this, and other, participating CAGE connected locations throughout the jurisdictions in which CAGE operates. These Rules and Regulations provide information regarding ULTRA CASH, including but not limited to, game specifications, playing conditions, requirements for claiming prizes, and disposition of fraudulent claims. These Rules and Regulations are on file at the CAGE offices and can be obtained by visiting the CAGE (St Kitts-Nevis) Ltd. website or an operating location where ULTRA CASH is offered to the playing public. This document will be available to all players who may have any questions regarding the ULTRA CASH Jackpot and the prizes that may be awarded to any participating player.

CAGE reserves the right, in its absolute and sole discretion, to make amendments to these Rules and Regulations.

1. Introduction:

1.1. These Rules and Regulations govern resolutions of all issues relating to the ULTRA CASH Jackpot, as organized and operated by CAGE. These Rules and Regulations also govern the relationship between CAGE and players of the ULTRA CASH Jackpot game.

1.2. These Rules and Regulations are subject to and issued consistent with the laws of St Kitts and Nevis ("St Kitts and Nevis") and any dispute or litigation that may arise from their application, compliance, interpretation or validity, will be resolved according to the laws of St Kitts and Nevis.

1.3. CAGE may amend these Rules and Regulations, at any time and in any manner, without prior notice to the players or third parties.

2. Eligibility to Play:

2.1. A player must be, at a minimum, 18 years of age to participate in the ULTRA CASH Jackpot game.

2.2. All directors, officers, shareholders and employees of CAGE, any CAGE retailer and their employees, any family members of retailer (as defined by CAGE) or employees of or persons supervised by retailer, are prohibited from playing any video lottery terminals (“VLTs”) or electronic gaming terminals (“EGM”) at CAGE venues or retailer locations and are not eligible to participate in or claim prizes from the ULTRA CASH Jackpot.

2.3. Players can only participate in the ULTRA CASH Jackpot through an authorized location of CAGE.

2.4. A player must completely and unconditionally accept and follow these Rules and Regulations in respect of the ULTRA CASH jackpot and/or any special rules and conditions promulgated by CAGE in its sole and absolute discretion.

2.5 All games on any video lottery terminal or electronic gaming machine at any CAGE connected location are included in the games of play from which an ULTRA CASH Jackpot or prize can be won, **with the expressed exception of the games of Poker, Blackjack and Roulette which are not included in the games qualified to participate in the ULTRA CASH Jackpot.**

3. Winner:

3.1 The winner of the ULTRA CASH Jackpot is centrally determined by the certified Random Number Generator (“RNG”), which selects the electronic gaming machine or video lottery terminal and thereby the player playing thereon, at the precise time the electronic gaming machine or video lottery terminal is selected by the RNG. The RNG selects the electronic gaming machine or video lottery terminal from among the CAGE connected electronic gaming machines and video lottery terminals in the multiple jurisdictions in which the ULTRA CASH Jackpot is available to be won.

3.2 The winner selected by the CAGE Central Operating System RNG from and as part of the connected electronic gaming machines or video lottery terminals must thereafter present himself/herself to the “in-location” Player Services Representative (“PSR”) immediately upon receiving notification of his/her selection as the winner of the current ULTRA CASH Jackpot. In addition, a winner must present himself/herself, at the earliest time possible, to the CAGE St Kitts and Nevis main offices to validate the status as the winner and complete the required compliance review and due diligence process (including, without limitation, AML, KYC and BSA reviews and analysis) prior to payment by check or bank transfer only. CAGE St Kitts and Nevis shall pay the ULTRA CASH Jackpot winner not later than seven (7) business days from the day the winner appears at the CAGE St Kitts and Nevis offices and completes the compliance and due diligence review. An ULTRA CASH Jackpot winner not presenting themselves for compliance and due diligence review to the CAGE St Kitts and Nevis offices within ninety (90) days of being selected as the ULTRA CASH Jackpot winner by the CAGE Central Operating System RNG shall forfeit

any and all claims, rights or interests in this specific ULTRA CASH Jackpot. CAGE shall so advise the public that the winner never appeared to claim the Jackpot and CAGE may, in its sole and absolute discretion, use or deploy these funds for charitable purposes in St Kitts and Nevis.

3.3 Separate and apart from any personal identification data that CAGE St Kitts and Nevis may have in its system or files on a player claiming to have won the ULTRA CASH Jackpot, the winning player shall also be required to provide to CAGE St Kitts and Nevis, a government issued “confirmation of identity” document with a photograph, that includes, inter alia, the following:

- a. Full Name
- b. Address,
- c. Telephone Number
- d. Date of Birth
- e. Occupation
- f. Document number
- g. Date issued
- h. Expiration date

4. CAGE Due Diligence and Verification of Winner Identification Data

4.1 CAGE shall, subsequent to a claim by the winner of the ULTRA CASH Jackpot, conduct its compliance and due diligence review within the seven (7) business day period including, without limitation, the following:

- a. The validity of the ULTRA CASH Jackpot winning on its operating system.
- b. Compliance and due diligence review including AML, KYC and BSA to validate and verify the identification of the winner.
- c. Determine percentage, if any, of the winnings which may be made available to the claiming winner pending completion of the seven (7) business day review period and verification of the identity of the winner.
- d. Confirm that the winner of the ULTRA CASH Jackpot is not, inter alia, an employee, officer or owner of CAGE or is not an agent or retailer of CAGE or an employee thereof and that the selected winner is qualified to receive the Jackpot.
- e. The Rules and Regulations of Play are, in all material respects, complied with and that the Jackpot as offered complied with the laws and regulations of St Kitts and Nevis.

4.2 CAGE may, from time to time, set in its sole and absolute discretion, Jackpots above a threshold amount (to be defined) that may go to the player’s mobile wallet but are expressly “restricted” (these restricted funds are viewable but not accessible, cashable or playable) for an initial period of seventy-two (72) hours from the time of the event, which 72-hour periods, may be extended by CAGE up through and including the end of the mandatory seven (7) business day period at which time the winner, having met and satisfied, all due diligence and compliance reviews, shall be paid (“Restricted”).

5. Issuance of Claimed ULTRA CASH Jackpot prize to Verified Winner.

6. The payment of the ULTRA CASH Jackpot prize shall be subject to and conditioned upon the laws of St Kitts and Nevis in respect of Withholding and Taxation of Winnings.
7. The ULTRA CASH Jackpot game and prizes thereunder shall be offered consistent with the highest international standards in respect of gaming, transparency, and best practices.
